

# Expression of Interest (EOI) Mining NL Board Positions

## Mining Industry NL Board of Directors 2025-2028

### Mining Industry NL is currently seeking Expressions of Interest (EOI) for three (3) positions.

1. Director - Exploration (2 positions);
2. Director - Service and Supply (1 position)

### Key Director Responsibilities

Directors shall hold office for three (3) years following their election. A director can offer their service for one additional term upon ratification by the Board of Directors.

### Board of Director Eligibility Requirements

(as per Mining Industry NL's By-Laws - Article 2 - Membership Eligibility, Section 2.1)

The membership of the Association shall be subdivided into categories as follows:

#### (a) Mineral Resources Companies

Any partnership, limited partnership, joint venture, syndicate, sole proprietorship, company or corporation directly involved in resource development or production.

#### (b) Exploration Companies

Any partnership, limited partnership, joint venture, syndicate, sole proprietorship, company or corporation directly involved in resource exploration.

#### (c) Service and Supply Companies

Any partnership, limited partnership, joint venture, syndicate, sole proprietorship, company or corporation indirectly involved in resource exploration, development or production.

#### (d) Other Members

Individuals and other entities which do not qualify as Service and Supply Companies but who wish to belong to the Association including, without limitation, public/educational institutions, prospectors and individuals. Members under this category shall be non-voting members of the Association.
